

2021 Fine Homebuilding 40th Anniversary Tips Video Contest

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN

ELIGIBILITY: The **2021 Fine Homebuilding 40th Anniversary Tips Video Contest** (the “Sweepstakes”) is open only to legal residents of the fifty (50) United States, plus the District of Columbia, Puerto Rico, and Canada, (except Quebec), who are at least eighteen (18) years old at the time of entry, and who are not employees, directors, officers, and contractors (including immediate family members and members of the same household) of The Taunton Press, Inc., (“Sponsor”) (“Administrator”), their respective affiliated companies, distributors, or vendors, or any other entities associated with this Sweepstakes (an “Entrant” or the “Entrants”).
